

NOTICE OF PUBLIC HEARING

The County Commissioners of Carroll County will hold a public hearing on October 28, 2010 at 10:05 a.m., in Room 311 of the Carroll County Office Building, 225 North Center Street, Westminster, Maryland, 21157, to hear public comments on the following proposed amendment to the *2007 Carroll County Master Plan for Water and Sewerage*:

Fall 2010 Special Amendment (Hampstead Community Comprehensive Plan) - Modify the Hampstead Water and Sewer Service Area maps and associated tables to reflect recommended changes contained in the recently adopted 2010 Hampstead Community Comprehensive Plan.

The purpose of the public hearing is to receive any statements or comments from persons wishing to speak on the proposed amendments. The Commissioners may make changes to the proposed amendments to the plan based upon the comments received, and may do so without further hearing. Both oral and written comments may be given at the hearing. Written comments may be submitted by mail as well, but will be considered only if received prior to the close of the hearing.
