

NOTICE OF PUBLIC HEARING

The County Commissioners of Carroll County will hold a public hearing on November 6, 2008 at 11:00 a.m., in Room 311 of the Carroll County Office Building, 225 North Center Street, Westminster, Maryland, 21157, to hear public comments on the following proposed amendments to the *2007 Carroll County Master Plan for Water and Sewerage* as part of the Fall 2008 Amendment Cycle:

1. **Hampstead Annexation No. 30 “Summit Street/Taylor Street” Annexation** - Reclassify twelve (12) properties totaling 7.239 acres from Future Water Service Area (W-5) to Existing/Final Planning Water Service Area (W-1) on the Hampstead Water Service Area Map (Map W-4).
2. **Hampstead Annexation No. 32 “Crockett Property”**- Reclassify one parcel of 0.541 acre from Future Water Service Area (W-5) to Existing/Final Planning Water Service Area (W-1) on the Hampstead Water Service Area Map (Map W-4).
3. **New Windsor Agricultural Easement Properties**- Reclassify two properties of approximately 96 acres from Priority Water and Future Sewer Service Areas (W-3 & S-5) to No Planned Service Area (W-7 & S-7) on the New Windsor Water and Sewer Service Area Maps (Maps W-7 & S-7).
4. **Liberty Road Crossing Multi-Use Systems**- Add to the *Carroll County Water and Sewerage Master Plan* a new Multi-Use Water Supply System and Multi-Use Sewerage System in the Priority Planning category that will serve the proposed planned business center known as Liberty Road Crossing.

The purpose of the public hearing is to receive any statements or comments from persons wishing to speak on the proposed amendments. The Commissioners may make changes to the proposed amendments to the plan based upon the comments received, and may do so without further hearing. Both oral and written comments may be given at the hearing. Written comments may be submitted by mail as well, but will be considered only if received prior to the close of the hearing.
