

NOTICE OF PUBLIC HEARING

The County Commissioners of Carroll County will hold a public hearing on May 27, 2008 at 2:30 p.m., in Room 311 of the Carroll County Office Building, 225 North Center Street, Westminster, Maryland, 21157, to hear public comments on the following proposed amendments to the *2007 Carroll County Master Plan for Water and Sewerage* as part of the Spring 2008 Amendment Cycle.

1. **New Windsor Planned Water Service Area (New Windsor Community Water Supply System)** – Correct the New Windsor Water Service Area Map (Map W-7) by reclassifying approximately 0.8 acre from ‘Priority Water Service (W-3) Area’ to ‘No Planned Water (W-7) Service Area’. The area is located at the eastern limits of the planned water service area, on the south side of MD 31 (New Windsor Road) and north side of the railroad tracks in Election District 11.

2. **Mount Airy Proposed Well and Waterline (Mount Airy Community Water Supply System)** – Add to the *Carroll County Water and Sewerage master Plan* a new municipal production well and new waterline that connects the well to the Town’s water distribution system. The new well is located near and south of Middle run, approximately 2,100 feet east of Watersville Road. The waterline begins at the new well site and extends approximately 10,855 feet southwest to the intersection of West Watersville Road and Arrowwood Circle in Election District 13.

The purpose of the public hearing is to receive any statements or comments from persons wishing to speak on the proposed amendments. The Commissioners may make changes to the proposed amendments to the plan based upon the comments received, and may do so without further hearing. Both oral and written comments may be given at the hearing. Written comments may be submitted by mail as well, but will be considered only if received prior to the close of the hearing.
